

Subject: Rajiv Gandhi University of Health Sciences, Bangalore - Renewal of recognition of DA qualification for 02 seats in respect of students being trained at M.V.J. Medical College, Bangalore.

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 27/10/2017 considered the Compliance Verification Assessment Report (05.10.207) along with the Council Assessor's Report (May, 2015 09.05.2016 & 09.03.2017) and compliance dated 09.06.2017 and 12.07.2017 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of DA qualification for 02 seats at M.V.J. Medical College, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (05.10.207) along with the Council Assessor's Report (May, 2015 09.05.2016 & 09.03.2017) and compliance dated 09.06.2017 and 12.07.2017 submitted by the college authorities and decided to recommend to the Central Government that the recognition of DA qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
