Sub: Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of D.O. qualification against increased intake from 1 to 2 seats and renewal of recognition for 1 seat in respect of students being trained at M.V.J. Medical College, Bangalore.

Sir/ Madam,

I am to state that the General Body of this council at its meeting held on 30/03/2016 considered the Compliance Verification Assessment Report (21/05/2015 for 1 to 2 seats) along with the Council Assessor's report (June, 2014 for 1 to 2 seats and May, 2015 for 1 seat) and compliance dated 17/11/2014 for 1 to 2 seats submitted by the college authorities on the standard of examination and other teaching facilities available at M.V.J. Medical College, Bangalore for purpose of Recognition of D.O. qualification against increased intake from 1 to 2 seats and renewal of recognition for 1 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (21/05/2015 for 1 to 2 seats) along with the Council Assessor's Report (June, 2014 for 1 to 2 seats and May, 2015 for 1 seat) and compliance dated 17/11/2014 for 1 to 2 seats submitted by the college authorities and decided to recommend to the Central Government that D.O. qualification against increased intake from 1 to 2 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee further decided to recommend to the Central Government that recognition of D.O. qualification for 1 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
