However, they shall apply afresh for Continuation of Recognition in 2024.

5. Accordingly, the approval of the competent authority in UGMEB is hereby conveyed for grant of **CONTINUATION OF RECOGNITION FOR ONE YEAR** for MBBS degree for 150 students, granted by Rajiv Gandhi University of Health Sciences, Karnataka in respect of the students being trained at MVJ Medical College and Research Hospital, Bangalore, Karnataka.
