
Sir/Madam,

Medical College and Research Hospital, Hoskote, Bengaluru under Rajiv Gandhi University of Health Sciences, Karnataka**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.*

2. The approval for Renewal of Recognition of MD(Anesthesiology) qualification for 07 seats is granted subject to applicability of amendments in NMC Regulations from time to time.
