I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 09/05/2017 considered the Compliance Verification Assessment Report (20/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 23/01/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MD(Anaesthesiology) qualification for 02 seats and recognition against increased intake from 03 to 04 seats at M.V.J. Medical College, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (20/03/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 23/01/2017 submitted by the college authorities and decided to recommend to the Central Government that the recognition of MD(Anaesthesiology) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be renewed.

The Committee also decided to recommend to the Central Government that the MD(Anaesthesiology) qualification against increased intake from 03 to 04 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
