Sub: Rajiv Gandhi University of Health Sciences, Bangalore - Renewal of recognition of MD(Psychiatry) qualification for 01 seat and recognition against increased intake from 02 to 03 seats in respect of students being trained at M.V.J. Medical College, Bangalore.

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Council Assessor's Report (15.07.2016) on the physical and other teaching facilities available at M.V.J. Medical College, Bangalore for Renewal of recognition of MD(Psychiatry) qualification for 01 seat and recognition against increased intake from 02 to 03 seats under Rajiv Gandhi University of Health Sciences, Bangalore and the Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (15.07.2016) and decided to recommend to the Central Government that the recognition of MD(Psychiatry) qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be renewed.

The Committee also decided to recommend to the Central Government that MD(Psychiatry) qualification against increased intake from 02 to 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
