The Board of Governors considered the assessment report (May, 2012) and noted that MD(General Medicine) is already recognized with 04(Four) seat(s) and decided to recommend that MD(General Medicine) against increased intake from 04(Four) to 06(Six) seat(s) granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 06(Six) students per year.
