

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MS(Otorhinolaryngology) qualification for 02 seats in respect of students being trained at M.V.J. Medical College and Research Hospital, Hoskote, Bengaluru under Rajiv Gandhi University of Health Sciences, Karnataka**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.*
- (ii) *The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.*
- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.*

2. The approval for Renewal of Recognition of MS(Otorhinolaryngology) qualification for 02 seats is granted subject to applicability of amendments in NMC Regulations from time to time.
