I am directed to state that the Board of Governors at its meeting held on 25.02.2019 considered the Compliance Verification Assessment report (03.12.2018) along with the Council Assessor's Report(s) (June, 2017, 21.03.2018) and compliance dated 06.06.2018 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS (General Surgery) qualification against increased intake from 04 to 06 seats at M.V.J. Medical College, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

*"The Board of Governors considered the Compliance Verification Assessment Report (03.12.2018) along with the Council Assessor's Report (June, 2017, 21.03.2018) and compliance dated 06.06.2018 submitted by the college authorities together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MS (General Surgery) qualification against increased intake from 04 to 06 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M.V.J. Medical College, Bangalore be renewed.*

*The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*
